102//18 Apologies for Absence

Apologies were received from Cllr P Sloan.

103/18 Declarations of Interests

Cllr Dalton, as a member of Chorley Council's Development Control Committee, declared a non-pecuniary interest in agenda item 5 (Planning Matters).

104/18 Minutes of the Meeting held on 8 October 2018

Resolved: the Minutes (as circulated) were approved and signed by the Chairman as a correct record.

Resolved: Standing Orders were suspended to allow members of the public to speak.

105/18 Public Participation

It was reported the 113 bus service is to be cancelled in January 2019.

Resolved: Standing Orders were restored.

106/18 Planning Matters

18/00918/CLEUD Certificate of lawfulness of existing use - siting of a caravan at Lodge House Farm, Dawbers Lane

18/00973/FUL Extension to agricultural building at Littlewood Hall Farm, Ridley Lane

Councillors had no objections to these applications.

18/00935/FUL Extension of 2no. existing detached steel portal frame buildings to form single building at Barlow Trailers & Livestock, Denizes Farm, Southport Road - concerns were raised regarding the continuous development of the site within the Green Belt however Councillors felt there were not sufficient material planning considerations for the submission of an objection.

109/18 Litter Picking Contract

The existing litter picking service provided by Eccleston Parish Council was reviewed. The hourly rate for 2019-20 will increase in line with inflation.

Resolved: the contract is to continue for the 2019-20 financial year.
