Resolved: the Minutes (as circulated) were approved and signed by the Chairman as a correct record.

## 61/22 Residents Surgery

Residents expressed serious concerns regarding a planning application for a children's home on Southport Road. The concerns were around the suitability of the location of the property which is on a busy main road, described by the Road Safety Foundation as one of the most dangerous roads, inadequate parking to allow for visitors and shift changes, limited public transport, lack of both leisure facilities in the vicinity and retail outlets within easy reach. The residents also raised concerns regarding the background of the company intending to operate the home.

Representatives from an agricultural property on Holker Lane advised of their intention to consult with residents regarding proposals to construct an anaerobic digestion system on the site.
